WHAT IS A PODIATRIST?

A podiatrist is a university qualified expert in foot-care. Podiatrists assess, diagnose, treat and prevent pain and injuries to your feet, ankles and lower limbs.

HOW CAN A PODIATRIST HELP ME?

A podiatrist can help manage all foot and lower limb related problems, including;

- Heel pain/plantar fascial pain
- Ingrown toenails
- Ingrown toenail surgery
- Wart treatment (including Swift microwave therapy)
- Diabetes foot assessments
- Orthotics and Biomechanical assessments
- Children's foot problems (flat feet, heel pain ,toe walking, intoe/pigeon toe)

- Skin and nail issues (fungal skin and nails, corns, thick nails)
- Ankle pain and sprains
- Bunions/big toe pain
- Ball of foot pain
- Stress fractures and management
- Arthritis in the feet
- Sports injuries
- Footwear assessment and advice

HOW CAN I ACCESS A PODIATRIST?

In most cases, a referral is not needed to book in with a podiatrist. However, if you have a referral please bring it with you to the appointment.

Veterans' Affairs, WorkCover, TAC and EPC/Care plan (Medicare) patients do require a referral to access the funding for podiatric treatment.

NDIS participants who are self or plan funded are welcome to book in to see how a podiatrist can help with your goals.
